Health & Safety: The NTET has a Health & Safety Policy designed to ensure that members understand their obligations to each other, as well as members of the public. Welcome Pack: Once your application has been processed, you will be sent, via post, a pack containing the latest issue of 'Steaming', a free back issue of 'Steaming' for further reading, your membership card, and an NTET car sticker. If you have supplied an email address, you will also receive login details to your membership account.

Gift Aid: Gift Aid is a scheme available to charities and Community Amateur Sports Clubs (CASCs). It means they can claim extra money from HMRC.

Under this scheme the NTET, as a registered charity, can claim an extra 25p for every £1 you pay as your membership subscription. That is as long as you've paid enough tax and make the donation from your own funds.

That means Gift Aid can increase the value of your subscription by 25%, and provide the NTET with further funds at no cost to yourself.
